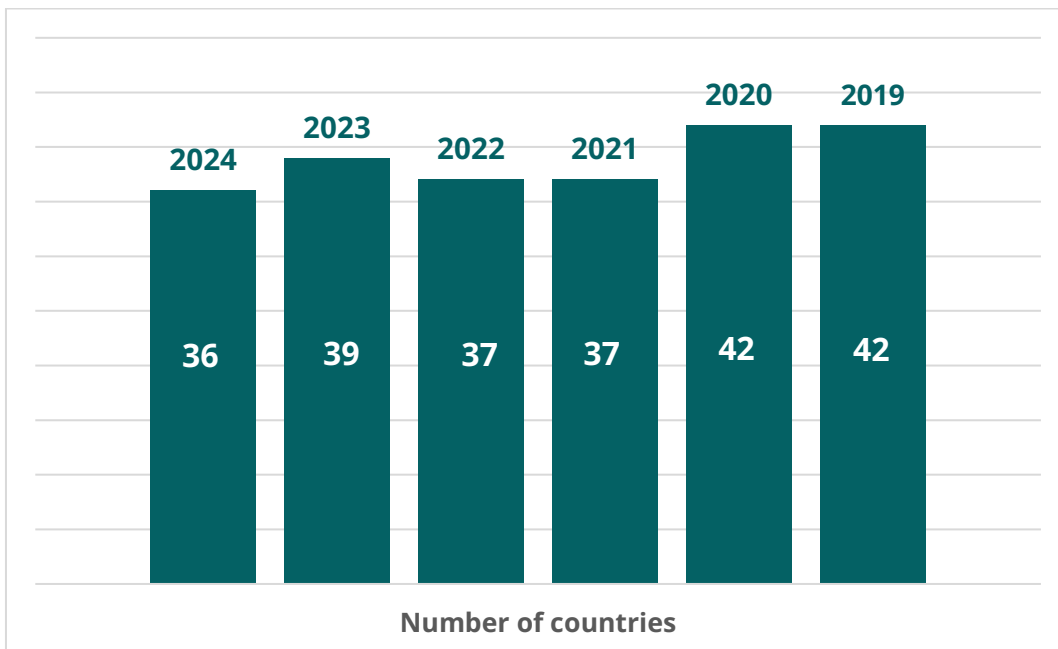
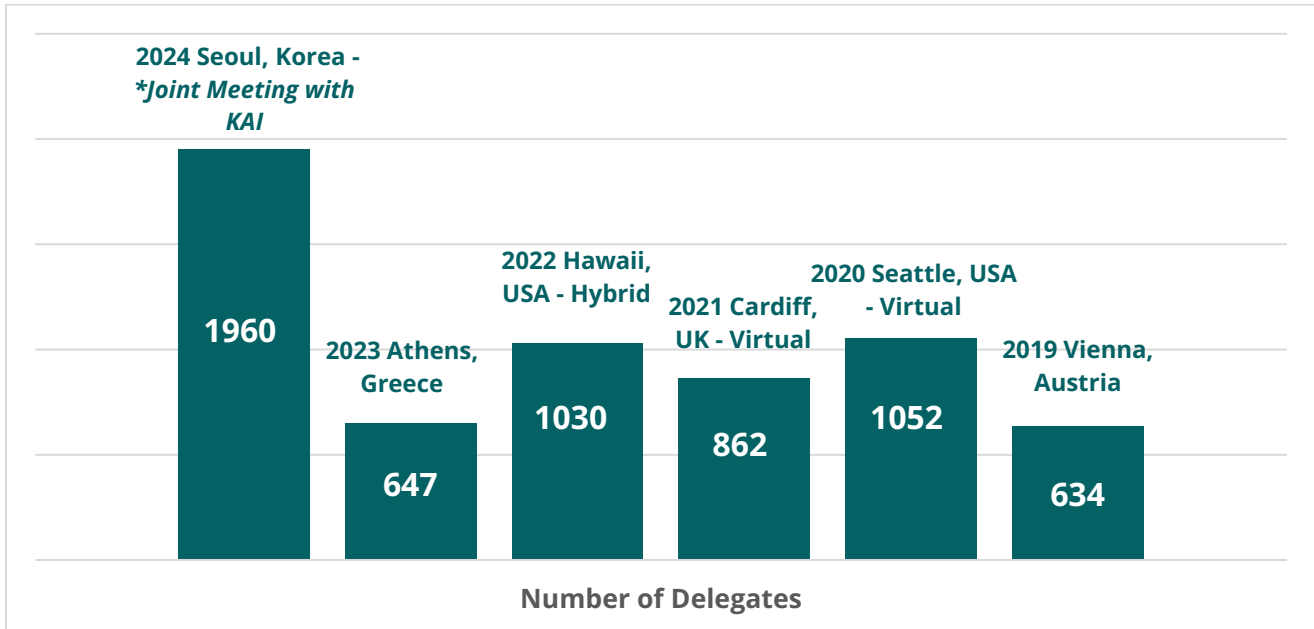

- 100% cancellation fee for cancellations of any orders thereafter
